## **Minutes of the January 14, 2013 Board of Directors Meeting**

The meeting of the Board of Directors of the Committee of One Hundred was called to order at 12:00 noon by President Mike Kelly. In attendance were Jim Bonner, Paul Rucci, Quint Crews, Ross Porter, Fern Murphy, Peggy Matthews, David Frost, Rich Bregante, Pamela Hartwell, Nancy Moors, Gerald Kolaja, Dick Lareau, Kay Rippee, Robert Wohl, Tom Jackson and Welton Jones.

**Minutes.** The minutes of the November 20, 2012 meeting were approved.

### **Old Business.**

C100 Holiday Party was successful, 35 attendees, enjoyable entertainment, \$19.04 above expenses. Thanks to Kay Rippee, Ross Porter.

Plaza de Panama. Start-up pending court decision expected in February.

### **New Business.**

2013 Awards. Members are asked to consider nominees for the annual C100 awards; the executive committee will select among those submitted.

Resolution County Grant. Pres. Kelly recommends we reapply for San Diego County Community Enhancement Program funds in fiscal 2013, specifically to support our Sculpture Court and Digital Archive projects. Motion made, seconded and approved to submit application.

### **Reports.**

Treasurer. Jim Bonner reports a steady improvement in total equity over the past three years. Current assets are \$168,277.81.

EBTC. Tom Jackson reports recent extensive water damage in the common area and below outside our C100 office in the Casa de Balboa due to an eruption of the café's espresso machine. Insurance should cover repair.

Tours: David Frost conducted a well-attended tour this past Wednesday.

President. Mike Kelly applauded Welton Jones for his BP 'Nudist Colony' presentation to the Hillcrest History Guild; he will repeat it for the San Diego Women's Club. Described Sandy Shapery's construction of a replica 1915 wicker electricque and a proposal for a number to be manufactured for use during the 2015 Celebration. Announced the death of Richard Amero, 2010 Gertrude Gilbert awardee. Another piece has been positioned in the Sculpture Court; a ceremony will be planned upon completion of the project. Work on the Digital Archive is progressing. Attended the celebration event for the Botanical Building Fountains restoration. Mike spoke at the Marjorie Crandall memorial service; several thousand dollars were donated to the C100 in her memory. Nancy Rodriguez has resigned from our Board. Irwin Jacobs stated on Voice of San Diego that he favors restoring the Science and Education Building, a position shared by C100.

There being no further business, the meeting was adjourned at 1:15 PM.

### Minutes of the February 4, 2013 Board of Directors Meeting

The meeting of the Board of Directors of the Committee of One Hundred was called to order 12:00 noon by President Mike Kelly. In attendance were Jim Bonner, Quint Crews, Ross Porter, Peggy Matthews, David Frost, Rich Bregante, Darlene Davies, Ron Buckley, Pamela Hartwell, Gerald Kolaja, Dick Lareau, Kay Rippee, Lynn Silva, Robert Wohl, Betsey Frankel, and Welton Jones.

**Minutes.** The minutes of the January 14, 2013 meeting were approved.

**Old Business.** Plaza de Panama. Mike convened the meeting with a mention about how crowded the court was when hearing the Plaza de Panama issue. Preliminary finding of judge was against the City, but he will take a few extra days to make his final decision. The issue was that the City failed to comply with its own law on “beneficial use.” Ron Buckley summed up the state of the legal argument, with Rich Bregante offering insight too. Sandor Shapery’s electric building and rental idea may no longer seem feasible without the permanent open space promised by the project.

**New Business.** 2013 Awards. The Board took up the Goodhue and Gilbert Awards for 2013, discussing the recommendations put forth by Executive Committee. Mike noted that key individuals such as George Marston and John D Spreckels are being “saved” for the 2014 and 2015 year awards. Darlene Davies asked for a reconsideration of the policy against recognizing Committee of One Hundred members so as not to penalize the good works of the likes of Bill Callahan, Sam Hamill, or Bea Evenson. Mike noted that Sam Hamill has been considered because of the work he did prior to the founding of C100. A discussion of a new “Founders Award” category was raised that could at some future time honor other Committee of One Hundred members.

On recommendation of the executive committee, Welton Jones moved that we give the Bertram Goodhue award to the Chamber of Commerce for its leadership role in the 1915 and 1935 Expositions. Seconded and Passed with note that it was the Chamber in 1909 where Aubrey Davidson first proposed an Exposition, and in 1934 the Chamber offered a platform for Gertrude Gilbert’s preservation message. Welton Jones moved to give the Gertrude Gilbert award to Ranger Kim Duclo. Seconded and passed after discussion regarding the length of Kim’s service and his unique leveraging of the Ranger’s job to support preservation concepts.

Richard Amero tribute. The Committee is considering a celebration of the life and work of Richard Amero (7-16-1924–12-22-2012), to be held either in the Casa del Prado or in the Committee of One Hundred office space. After discussion of possible memorials (bench, plaque) and who might be invited, Mike asked the board to offer further thoughts. Welton Jones’ motion was seconded and passed that C100 hold an event to recognize the life and career of Richard Amero.

**Reports.** Treasurer Jim Bonner submitted his report.

There being no further business, the meeting was adjourned at about 1:30 PM.

**Minutes.** The minutes of the February, 2013 meeting were approved.

**Old Business.** Plaza de Panama and Centennial. Judge ruled against Plaza de Panama project. Deadline for appeal comes later this month, city appears to have decided to do nothing, after a long closed session. Sale of bonds for Organ Pavilion parking structure approved by City Council last September, anticipating Plaza de Panama project would go forward. Steve Hill told Mike it will likely remain dormant [bond approvals have a 12-month shelf life, then expire]. Tom Jackson noted article in today's U-T re Tourism and Marketing District dispute with Mayor Filner. Mike talked with Ben Clay who is discouraged at Filner's holding up funds, which would put 2015 Celebration out of business by June. Ron adds that there was a contract to purchase a tram. Mike was told it was ordered by David Kinney. Mike will try to determine exactly what was bought. The Mayor plans will make a minor change to traffic pattern in Plaza de Panama, eliminating parking as in the Balboa Park master plan.

2013 Awards. Ranger Kim Duclo was pleased to be notified re Gerturde Gilbert Award. Stacey LoMedico approved his accepting it. Mike has confirmed the date with Jerry Sanders' Executive Asst at the Chamber of Commerce but he remains in Europe. Welton proposed asking the Board Chairman to accept but the decision is up to the Chamber.

Richard Amero tribute was hosted by C100 in our office, about 25 attended a nice event. Special thanks to Pam Miller and Lynn Silva for a very nice food and wine selection.

C100 Annual Meeting will be on FRIDAY MAY 31. Planning session will be held Monday 3/25 at 10:30 in C100 office. All board members wanting to be involved are welcome to attend. Quint Crews would like to stop taking reservations and making table assignments, and would like to teach the system to someone else this year with his help. WE NEED A BOARD MEMBER OR SPOUSE TO ASSUME THIS JOB.

**New Business.** Lynn Silva sent out survey to suggest new board members. Several additional names were brought up and will be kept on a separate list for now.

**Reports.** Treasurer Jim Bonner submitted his report and questions were answered. Tom Jackson gave update on the EBTC, Gro café and flood followup. Mike Kelly reported that several board members attended Jack Krasovich's funeral at Miramar. Chris Christoph has been in the hospital for several months; Joy Ledford is recovering from a fall the night of our holiday party. That organization was responsible for accepting G Aubrey Davidson's idea for an Exposition to celebrate the opening of the Panama Canal in 1915, and creating the Company that would bring it about. The Goodhue award was accepted by former mayor Jerry Sanders, now president and CEO of the San Diego Regional Chamber of Commerce.

**Guest Speaker Jean Stern**, Executive Director of the Irvine Museum, gave a well-received presentation on the Modern Art Exhibit led by Robert Henri at San Diego's 1915 Exposition. The exhibit was not well attended, though it was on display for most of the year in the Fine Arts Building, the low, mission style building directly across from the California Building.

Ross Porter led the raffle, thanked those who helped make the event a success, and made closing remarks and the meeting was adjourned at 1:40 PM.

**Minutes of the October 21, 2013 Board of Directors Meeting**

Attendees: Mike Kelly, Ross Porter, David Frost, Peggy Matthews, Nancy Moors, Welton Jones, Ron Buckley, Rich Bregante, Tom Jackson, Quint Crews, Pam Miller, Jim Bonner, Bob Wohl and Gladys Jones

Guest presentation: Jesus Benayas, President of the House of Spain, cited a dozen collaborative projects between the House of Spain and other San Diego organizations. Sept 25 marked 500 years since the discovery of the “South Sea” by Vasco Nunez de Balboa, but there was a surprising lack of commemoration – why no statue of Balboa? The House of Spain has no definite recommendation for a location of a statue, but are preparing an application and need support. One possible spot would be the south end of the Esplanade, or at the 6<sup>th</sup> avenue entrance to the park. Jarez de los Caballeros is the city in Spain where Balboa was born, and there is a statue there from which a likeness may be developed; there are descendants there also. There may be paintings or busts. Ron suggested that off the Central Mesa is a preferred location so as to retain the historic character of the Central Mesa. Jim thought a bas-relief of Balboa could be part of the decoration added to the Administration Building. Mike noted a tribute to Balboa in the cartouche near the statue of El Cid. Ross moved and Pam seconded the concept of a formal recognition of Balboa in a location off the Central Mesa. This was tabled.

**Minutes** of the last meeting were approved by consensus.

**Old Business**

Plaza de Panama: a propane tank is now installed for the new shuttles at the old stable location in Gold Gulch. An RFP is going out for operators though Mike was uncertain whether this has yet been issued. The city is ready to put trees in new 3-ton planters in the Plaza – Evergreen Elms. Changes to the Alcazar Garden lot are long in coming, and the delay is upsetting to the parking public who seek blue spaces. The Valet drop-off is working well enough.

Sculpture Court: the two large columns are done and returned. The final phase consisting of cleaning the Three Spanish Artists is now beginning at a cost of \$3200 per figure. The Right of Entry permit covers one more year. Pam asked about showing an un-restored piece.

Digital Archive: the Website is now under development; Mike spoke to a group of 30 at a brownbag luncheon at KPBS where he got a City-issued certificate.

Amero book: Mike is reviewing page layout. The History Press plans to go to press in mid-November with sales available before Christmas.

## **New Business**

Zoo Employee Parking Structure Proposal: it is being fast-tracked on the basis of the Zoo's claim that the city has already ok'd a parking structure off Highway 163. Mike is concerned about the traffic distracting patrons of the Old Globe's outdoor Festival Stage and traffic on Old Globe Way and Village Place. Discussion of other locations for parking structure with entry from Richmond. An info briefing for the Balboa Park Committee has articulated the footprint and traffic access.
